1. Background

The Joint Songwe River Basin Commission (SONGWECOM) is a bi-national institution established by the Governments of the United Republic of Tanzania and the Republic of Malawi to promote sustainable management and development of the Songwe River Basin.

SONGWECOM invites quotations from qualified and experienced motor vehicle service providers for the provision of routine servicing, maintenance, repair, and standby generator maintenance services for its fleet and equipment located at the Secretariat Offices in Kyela, Tanzania, for the Financial Year 2026/2027.

The selected service provider shall be responsible for routine preventive maintenance, corrective maintenance, repairs, and supply of necessary technical support services for motor vehicles and standby generators throughout the contract period. The service provider Office should be located in Mbeya Region, Tanzania.

2. Objectives

The objective of this assignment is to engage a competent service provider to:

- a) Ensure vehicles and generators remain in good operating condition.
- b) Minimize equipment downtime through preventive maintenance.
- c) Improve reliability, safety, and efficiency of SONGWECOM vehicles and generators.
- d) Provide qualified personnel, tools, equipment, and technical expertise for servicing and maintenance.

3. Scope of Services

The service provider shall provide servicing and maintenance services for SONGWECOM vehicles and standby generators, including but not limited to:

A. Routine Vehicle Servicing

The services shall cover routine servicing based on mileage and hours intervals as follows:

- i. Minor Service – 5,000 km
- ii. Medium Service – 10,000 km
- iii. Major Service – 20,000 km
- iv. Comprehensive Service – Above 40,000 km

The vehicle fleet includes:

B. Corrective Maintenance and Repairs

The successful bidder shall provide maintenance services as required depending on breakdowns for:

- i. Double Cabin
- ii. Station Wagon
- iii. Generators (Diesel Power)

Services may include:

- a) Engine repairs
- b) Transmission repairs
- c) Suspension repairs
- d) Electrical repairs
- e) Brake system repairs
- f) Cooling system repairs
- g) Body repairs and painting
- h) Welding and fabrication works
- i) Generator servicing and repairs
- j) Replacement of worn-out parts
- k) Emergency breakdown services

4. Duration of Contract

The contract shall be for a period of two (2) years from the date of signing the agreement.

5. Payment Terms

- a) Payment shall be made based on services rendered.
- b) Invoices shall clearly indicate vehicle registration number, service type, and work performed.
- c) Payment shall be made within thirty (30) days after receipt and verification of invoices.

6. Repairs and maintenance works resulting from breakdowns shall be invoiced separately upon approval by SONGWECOM.

7. Minimum Requirements

Interested firms must submit evidence demonstrating compliance with the following requirements:

6.1 Company Registration

The bidder shall possess:

- a) Certificate of Incorporation.
- b) Valid Business License.
- c) TIN Certificate.
- d) VAT Registration Certificate (where applicable).

6.2 Technical Capability

The bidder shall demonstrate:

- a) Experience in vehicle and generator servicing and maintenance.
- b) Availability of qualified mechanics and technicians.
- c) Availability of workshop facilities and service equipment.
- d) Capacity to undertake emergency repairs and maintenance.

6.3 Personnel

The bidder shall provide information on:

- a) Managing Director.
- b) Workshop Manager.
- c) Operations Manager.
- d) Auto-Electrical Advisor.
- e) Accountant.

The bidder shall attach qualifications and experience records of proposed personnel.

6.4 Equipment and Workshop Facilities

The bidder shall demonstrate ownership or access to the following equipment and tools:

- a) Complete heavy-duty vehicle repair tool box.
- b) Complete light-duty vehicle repair tool box.
- c) Auto-electrical repair tools.
- d) Panel beating and painting tools.
- e) Arc welding machine.
- f) Oxy-acetylene welding and cutting equipment.
- g) Safety gears and PPE.
- h) Battery charger (12/24V).
- i) Hand drills.
- j) Lubrication equipment.
- k) Tyre fitting equipment.
- l) Hydraulic pressing machine (minimum 150 tons).
- m) Air compressor.
- n) Vehicle jacks (3 ton, and 5 ton).
- o) Crane/Chain block (5 tons).

- p) Fire-fighting equipment.
- q) Mechanical pullers.
- r) Piston ring squeezers.
- s) Diagnosis Machine
